Guide for Authors

Preparation of Papers. All papers must be in English. Preparation of the manuscript in some form of TeX such as LaTeX, AmS-TeX, or AmS-LaTeX is highly recommended.

Each manuscript is required to contain an abstract, clearly separated from the rest of the paper, which will be printed immediately after the title. In the footnote of the first page, the following information should be given: AMS 2000 subject classifications, and key words and phrases. The affiliation(s) of the author(s) should be given at the end of the paper.

Formulas in the text should be written with a solidus or negative exponent; for example, a/b instead of $\frac{a}{b}$ and $(2a)^{-1}$ or $1/(2a)$ instead of $\frac{1}{2a}$. Also, $\sum_{i=1}^n a_i$ and $\prod_{i=1}^n a_i$ should be used in the text instead of $\sum_{i=1}^n a_i$ and $\prod_{i=1}^n a_i$, respectively.

References should be listed alphabetically in the following style:

Submission of Papers.

1. Electronic Submission: A PDF file of the manuscript can be submitted by e-mail to the Editorial Office: journal@math.tsukuba.ac.jp. If accepted for publication, the source file of the manuscript should also be sent to the Editorial Office.
2. Non-Electronic Submission: Papers to be submitted for publication should be sent to the chair of the editorial committee. The original manuscript should be submitted in duplicate. Copies of unpublished or not easily accessible papers of the author(s) cited in the manuscript should be submitted along with the manuscript.

Copyright. By submitting a manuscript to *Tsukuba Journal of Mathematics*, the authors agree that the copyright to their manuscript is transferred to the Publisher of the journal, Institute of Mathematics, University of Tsukuba, if and when the manuscript is accepted for publication in *Tsukuba Journal of Mathematics*. The copyright covers the right to reproduce and distribute the manuscript by means of printing, reprinting, or any other means which is deemed appropriate by the Publisher, including electronic media, photographic reproductions, microfilms or any other reproductions of similar nature, as well as translations. The authors reserve the following rights:

(1) The right to use all or part of this manuscript in future works of their own, such as lectures, lecture notes, press releases, reviews, and textbooks.

(2) The right to keep the manuscript, after it has been published, on any preprint server or the authors' Web sites for research, education and other academic purposes.

Offprint policy change notice. From vol. 40, free hard-copy reprints of the published articles will no longer be provided. Instead, each corresponding author will receive the PDF file of the article. Hard-copy reprints, minimum 10 copies, are provided upon the request and at the expense of the author. The charge for hard-copy reprints depends on the manuscript page length.

- 1–8 pages 80 yen/copy
- 9–10 pages 100 yen/copy
- 11–12 pages 120 yen/copy

Manuscripts of more than 12 pages are charged for additional pages at 20 yen/2 pages/copy. For example, 30 reprints of a 15-page manuscript will be charged $160 \times 30 = 4,800$ yen. An extra charge of 5000 yen is added for reprints with journal covers.
